Whitton asked where staff would begin to look into the AEAS program. David D. King responded that there is an airline that provides AEAS at other airports and that staff could start by contacting them. Megan J. M. Whitton asked if this airline provides service at any local airports. Executive Director Steven J. Lawrence responded that it flies out of 8 or 9 airports throughout the country, but that none of them are in the Northeast. David D. King moved, seconded by Jennifer Quirk-Pickman, that the Board will direct staff to explore AEAS and report back to the Board at the next meeting.
